This has reference to your application under reference above, it is to inform that M/s. Anand I. Tripathi, Dadra has applied for renewal of fire NOC of the Residential Cum Commercial Building having on ground floor + 02 Upper floor with total height of 11.58 meters from the general ground level up to the terrace level on land bearing Survey No. 20/4p, 20/7, 21/1, 21/2, 20/6, 20/7, 22/1, 22/4, 23/1, 23/2, 31/3, 31/5, situated at Village – Dadra.

While fire safety inspection held on 18.07.2022. It has been found that at present School is functioning in the proposed building, whereas the fire department has issued provisional fire NOC as well as final fire NOC for Residential cum Commercial building. "As per National Building Code of India, the School building and residential Cum-Commercial building both are separate occupancies and its life & fire safety measure are also different".

Therefore, Fire department is not permitted to functioning School in the proposed building from the fire safety point of view and safety of the public unless until fire & life safety measures are not complied as per particular occupancy (Educational Building).
